


Prerequisite Data for Documents Guide

Some documents in SoftPro Select require specific data in the order. If the order does not have the data, when you attempt to generate one of these documents, a window appears informing you that there is insufficient data.



For example, if you are attempting to generate a **1099 Reporting** document, the SoftPro Select order must have a Seller Contact.

Use this guide as a reference to identify the data required to generate the following documents:
