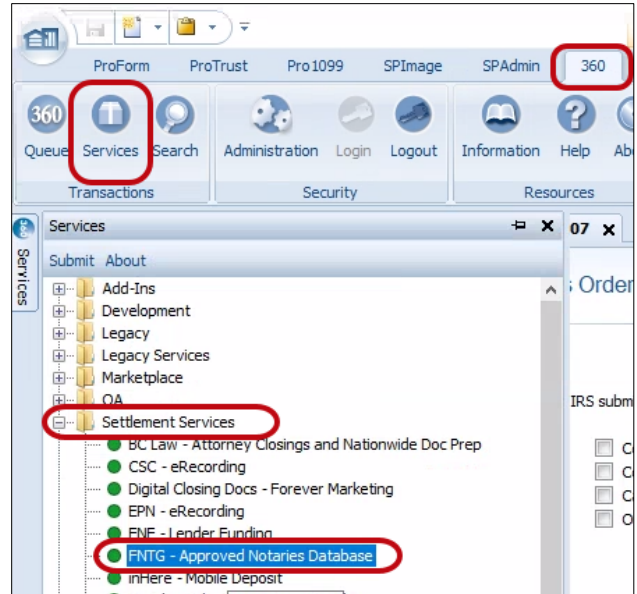


## Using to Search and Select a Subcontractor

When searching for a notary it may become necessary to use a subcontractor rather than a direct notary. Follow these steps to search for and select an approved notary from the FNTG – Approved Notaries Database.

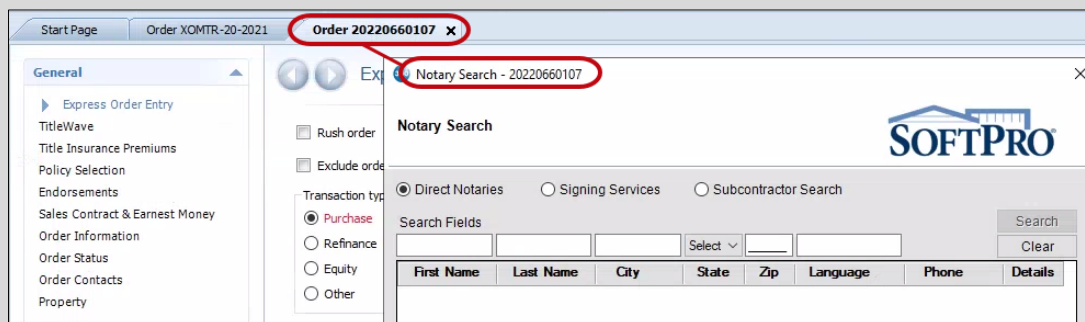
From the **360** ribbon,

1. Click the **Services** button
2. Expand the **Settlement Services** folder
3. Select the **FNTG – Approved Notaries Database** entry



**NOTE:** The **Notary Search** window automatically opens if,

- » One order is open and cites that order number
- » Multiple orders are open – the active order is presumed the order you are performing the search for, if not, close the **Notary Search** window and click on the corresponding order before opening the integration.



If no order is open, you are prompted to enter an order number.

## Using to Search and Select a Subcontractor

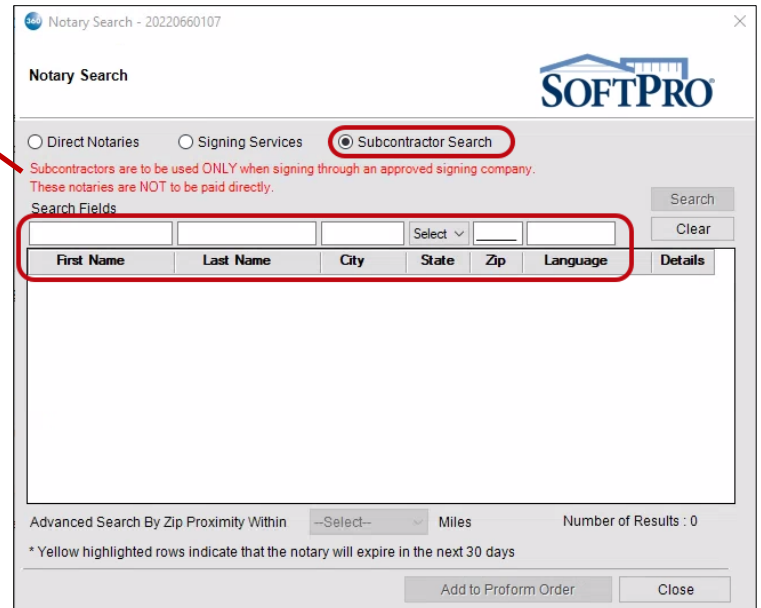
- Select the **Subcontractor Search** option

**NOTE:** The Subcontractor must be through an approved signing company and paid through the signing company. When the Subcontractor option is selected a message displays as a reminder.

- Enter search terms in the **Search Fields**; these appear above the column names and correspond to the column names

At least one search criteria must be used to perform a Subcontractor search.

- Click the **Search** button

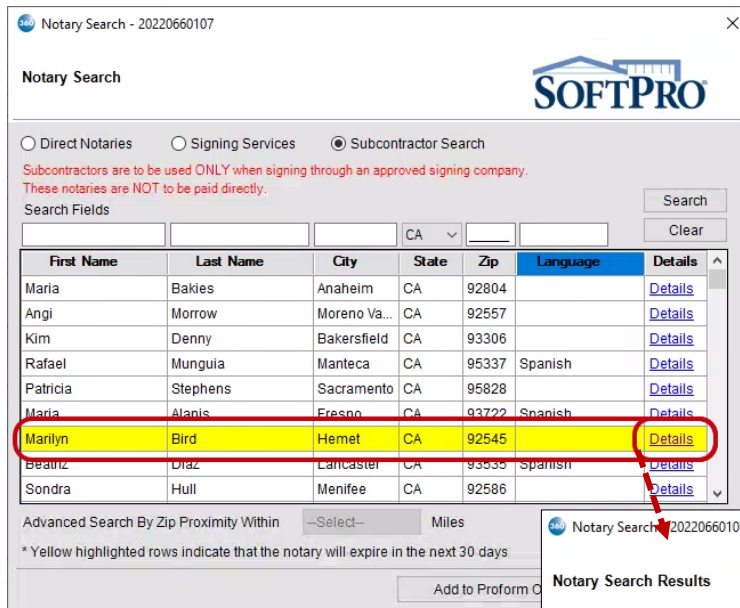

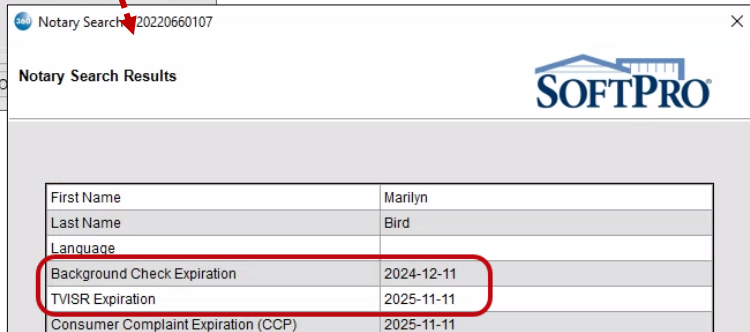

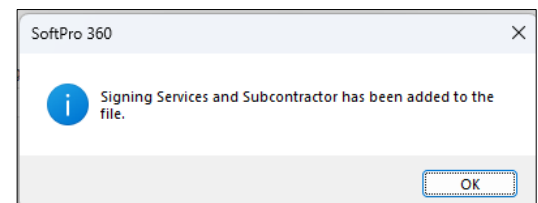
