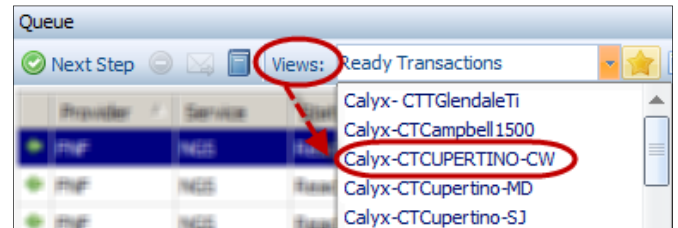


Follow these steps to cancel a Calyx order.

1. From the **360** ribbon, click the **Login** button
2. Once logged in, click the **360 Queue** button



3. From the **Views** drop-down, select your **Saved View**



Your Queue populates with all Calyx transactions for your Branch.

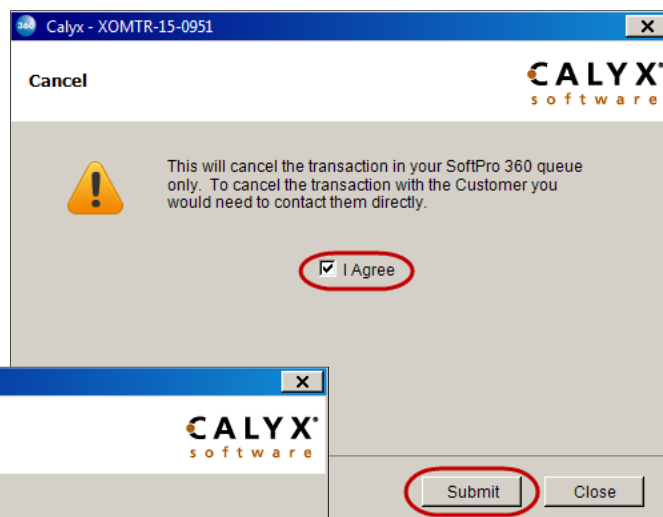

5. Click the **Cancel** icon

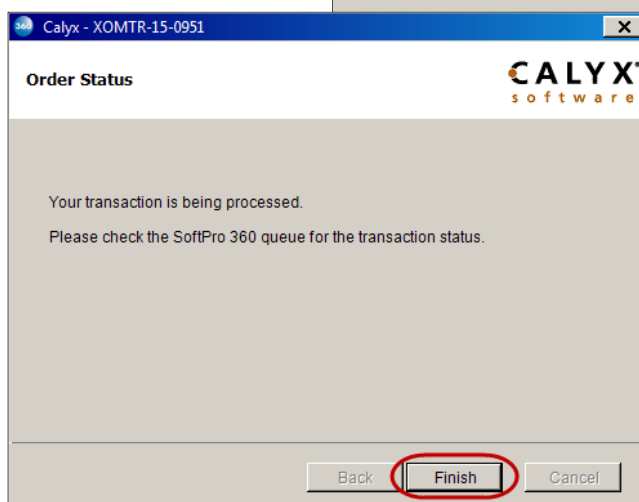

6. Check the **I Agree** check box; click **Submit**




7. From the **Order Status** window, click the **Finish** button

10. Repeat **Steps 5-7**


